Calculation of Import Port Storage time starts the day after container discharge and ends when container departs from the terminal via gate or rail.

Storage Calculation Domestic units

Calculation of Port Storage time starts on the day container is gate into the terminal and ends the day container is departing.

Temperature controlled units, units containing dangerous goods, and OOG units have the same free Port Storage terms as described above.
