## APM Terminals Pipavav is now AEO LO certified

APM Terminals Pipavav is pleased to inform that the Port has obtained the AEO LO Certificate. This certification would facilitate importers and exporters using the port to be included for DPD [Direct Port Delivery] for Importing Goods / Containers and DPE [Direct Port Export] for Exporting Goods / Containers. Further the port being AEO LO certified, an importer / exporter can opt for AEO T3 certification which provides high level of facilitation, zero container scanning (except on specific intelligence) no requirement of bank guarantee etc.

# Faster Vessel Turnaround: Inward entry simplified

APM Terminals Pipavav has now received Customs Permission to commence Container Vessel operations immediately after berthing of vessel. As per the Public notice issued by Hon Commissioner of Customs (Jamnagar), now entry inward for containerized cargo vessels berthing at Pipavav Port, will be done at the time of pilot boarding itself.

This will allow vessel operations to be commenced immediately upon vessel berthing thus saving the time lost in granting of permission after customs boarding and inspection. This will enable faster turnaround of vessels and lower costs for Shipping Lines calling at Pipavav.
